

Kermit A. Crawford, Ph.D. Emeritus Clinical Associate Professor Department of Psychiatry Boston University School of Medicine

Dr. Kermit A. Crawford, is Clinical Associate Professor Emeritus from the Boston University School of Medicine formerly Associate Professor and The Avalon Endowed Chair of Psychology at Hampton University. He is a licensed Psychologist, teacher, researcher, and consultant. He was Principal Investigator and Executive Director of a \$17,700,000 Reimagining Workforce Grant from the U.S. Department of Education (2020) until October 31, 2022. Dr. Crawford is formerly Director of the Center for Multicultural Mental Health (CMMH) at Boston University School of Medicine and Boston Medical Center and Executive Director of the Massachusetts Marathon Bombing Victims/Survivors Resiliency Center. He has done extensive work in multicultural behavioral health disaster response, trauma, addictions and culturally-informed practices across the nation. Crawford is the recipient of several national, state and local awards, citations and recognitions. He is a former member of the National Center for Injury Prevention and Control's Board of Scientific Counselors for the Centers for Disease Control and Prevention (CDC) and the Committee on Developing Evidence-Based Standards for Psychosocial Interventions for Mental Disorders Institute of Medicine (IOM). He is currently a member of the Disaster Behavioral Health Response Cadre of the Substance Abuse and Mental Health Services Administration (SAMHSA), and others. In addition to his earned doctorate from Boston College, he is recipient of an honorary doctorate from William James College. Dr. Crawford is a former Psychologist for the National Football League (NFL) assigned to the New England Patriots.

LaConda G. Ambrose Fanning, Psy.D, is a Licensed Professional Counselor, Licensed Substance Abuse Treatment Practitioner, and Registered Nurse. She holds a Doctorate in Clinical Psychology from Regent University with a concentration in Organizational Consultation and Supervision. Dr. Fanning is a part of the Eastern Virginia Medical School with the office of Graduate Medical Education. Dr. Fanning serves as the Director of Assessment and Mentorship Program, the Diversity, Equity and Inclusion Officer, the Associate Director of the BNGAP Academic Fellowship Program and has a Faculty Appointment with Internal Medicine. Dr. Fanning has a special interest in health equity, diversity and inclusion, religious coping, and generational effects of trauma with URM's. In the community, Dr. Fanning serves as the President on the Executive Board of the Virginia Counseling.

Paul is a licensed clinical social worker with a master's degree in social work from the University of Connecticut. He has worked in the field of mental health services for 15 years and currently serves as the team lead for partial hospitalization and intensive outpatient programming at Sentara's Center for Behavioral Health in Virginia Beach, VA.

Cristina Bain, Ph.D. Psychology Program Manager & Assistant Director, PCMHI, Hampton VAMC

Dr. Bain received her master's degree in substance abuse treatment psychology from the University of North Carolina Wilmington. She received her doctorate from the Virginia Consortium Program in Clinical Psychology and completed her internship at the Hampton VAMC before joining the Primary Care Mental Health Integration team.

Janette Mance-Khourey, Ph.D., LCP Psychology Program Manager & Director, PCMHI, Hampton VAMC

Dr. Mance-Khourey received her doctorate from the University of Akron, completed her internship at the Hampton VAMC and a post-doctoral fellowship in Integrated Behavioral Healthcare at Eastern Virginia Medical School before returning to the VA to work in PCMHI. She a VA mobile Health (mHealth) specialist, a trainer for VA's national PCMHI Competencies Training program, and a VA Master Trainer in Problem-Solving Training (PST).

State of Behavioral Health in the Commonwealth

Nelson Smith

Commissioner, Department of Behavioral Health and Developmental Services

Objectives:

 Identify challenges facing Virginia's mental health services and systems and examine how state policies and initiatives are driving change.

Nelson Smith was appointed by Governor Glenn Youngkin in 2022 to be the commissioner of the Virginia Department of Behavioral Health and Developmental Services (DBHDS), a state agency that operates 12 state hospitals and facilities with over 6,000 employees, and oversees a \$2.5 billion system that annually serves 217,000 Virginians and families struggling with behavioral health disorders and developmental disabilities. He continues to prioritize the most vulnerable and overlooked populations in society, ensuring they receive the highest quality of care. With a strong foundation in faith, family, and love of country, Nelson remains dedicated to improving the lives of those he serves.

On January 1st of 2020, Colin attempted suicide, and since then he has been dedicated to ending the stigma around mental illness.

Director of Research, Center for African American Public Policy (CAAmPP) Assistant Professor, Sociology and Urban Affairs, NSU, Department of Sociology

"The Invisible Pain: Exploring the Mental Health Crisis in the Black Community" Objective(s):

- Develop an understanding of the unique challenges faced by Black individuals
 with mental health concerns, and apply this knowledge to provide culturally
 sensitive and appropriate care to Black patients.
- Identify the social and systemic factors contributing to the mental health crisis in Black communities, and develop strategies to promote mental health equity and reduce disparities in mental health care for Black individuals.

Dr. Goler is a thought leader dedicated to bridging the gap between research and practice to promote equity and opportunity for marginalized communities. With over 25 years of experience in public, private, and nonprofit sectors, he brings a multidisciplinary approach to his work, addressing complex issues such as the environment, lifestyle, identity, and the impact of racism and discrimination on health outcomes.

Ajay Manhapra, MD Section Chief, Pain Medicine, Hampton VA Medical Center

Dr. Manhapra is a clinical expert in recovering people with disabling chronic pain and comorbidities who have failed years of pain management, surgeries and other treatments. His research is focused on the intersection of pain, physical disorders, mental illness, and recovery from disability. He has published over 50 peer reviewed manuscripts and book chapters.
